Students have to report to the college with following documents

- 1. Printout of the college admission form from www.lsraheja.org
- 2. Printout of the Government Online form (VERIFIED Part-1 Registration and Part-2 Option Form).
- 3. 10th standard marksheet (Original + 3 copies)
- 4. 10th standard Leaving certificate (Original + 3 copies)
- 5. Copy of Aadhar Card
- 6. Residential Address proof (light bill, phone bill, gas bill etc)
- 7. Gujarati Linguistic Minority certificate (Issued by the head of the Registered Community/Samaj from Maharashtra on its letter head)(Only for Gujrati linguistic minority students)
- 8. Copy of Ration Card (Only for girl students)

Note:

- 1. For IN-HOUSE ARTS QUOTA admission, students should have passed SSC examination from MALATI JAYANTI DALAL SCHOOL in March 2022 only as regular student and should have applied for In-house Quota in the portal www.11thadmission.org.in
- 2. For MINORITY GUJARATI QUOTA, students should have applied for Minority Quota in the portal www.11thadmission.org.in
- 3. ATKT AND REPEATER STUDENTS SHOULD NOT APPLY for MINORITY GUJARATI and IN-HOUSE QUOTA.
- 4. For MINORITY GUJARATI QUOTA, students should have passed SSC or Equivalent examination from Maharashtra State in March 2022 only as regular student & the mother tongue is GUJARATI.
- 5. Students who fail to submit the original documents and pay the fees within the stipulated time period, for any reason, shall loose the claim for admission and shall not be considered for admission in subsequent merit list.
- 6. Admission to any student will be granted purely on provisional basis.
- 7. Name in the Merit List does not guarantee admission. Admission will be done strictly on the basis of actual physical verification of the original documents. ADMISSION WILL BE CANCELLED if any discrepancies in the document, found at any stage during the admission process or thereafter.
- 8. Incomplete application forms will not be accepted.
